### CHAIRMAN'S REPORT

My 21st year at ECU has been an eventful one! Some of you may have missed that I am now serving as the Department Chair. It took me 20 years to finally talk the Dean into this! Seriously though, what an honor to represent our faculty, our students, and our alumni.

I was able to confirm in my first year on the job that we have an amazing faculty. After adjusting in 2020 to the craziest Spring semester ever, faculty began the Fall 2020 semester, not only teaching in a full pandemic, but also teaching in two 8-week blocks versus the traditional 15-weeks. Our faculty did not just adapt, they excelled. They held live virtual office hours, created hands-on video lectures and demonstrations, and to the extent possible, accommodated students' individual learning requests. In addition to teaching, they published research articles, kept student clubs, fraternities, and recruiting events going, served on university, college, and

department projects and committees, and served the community. The University operates from a model called shared governance, which means that faculty members are an integral part of the University's oversight functions. Our faculty continued executing their shared governance-responsibilities and did more. In their personal time, they also volunteered at organizations like the Ronald McDonald House and local animal shelters.

Our students, for whom the shared governance model also applies, are equally as impressive. Many of our students serve as leaders in student government, Greek organizations, Student Accounting Society, Beta Alpha Psi, and more. While adapting to the virtual learning environment and dealing with COVID, they continued to actively participate in these organizations. We have several student-athletes that not only had to miss a season of competition, but they also found out that due to State budget constraints their sport was eliminated. Some students faced greater hardship than others, but all persevered. You can read some of their stories in this newsletter.

I would be remiss if I didn't mention our great alumni. Through my travels around NC, I engage with more and more graduates every year. The Accounting Pirate Nation is growing in the business community and at the University. On March 17<sup>th</sup>, ECU held its annual day of giving, which is referred to as Pirate Nation Gives. This year, the Accounting Department had more donors than any other department on campus!! Over 80 alumni and faculty gave over \$44,000 to the Accounting Department in a single day. We are the envy of every department on campus. Your donations make a difference in a lot of students' lives. This year alone, we were able to award 39 scholarships totaling \$111,950.

In addition to helping our current students financially, we are making sure that an accounting education is available to everyone that wants it. Demand is strong for an ECU accounting degree, so for students that can't get to Greenville, we plan to take a degree to them. Beginning Fall 2021, our BSBA will be offered both face-to-face and fully online. Our goal is to add a fully online MSA in Fall 2022. So, keep giving and promoting ECU!

We are grateful for every donation, no matter its size. Every dollar makes a difference. If even 10-percent of our nearly 3,000 accounting alumni gave back, we could do so much more to improve the current student experience, attract and retain future students, and increase the number of Pirate alums. 






### OUR FACULTY... are Research-Focused

**Dr. Cal Christian** updated his CPE courses "North Carolina Accountancy Law: Ethics, Principles & Professional Responsibilities," and "North Carolina Professional Ethics." Since 2010, the accounting faculty has teamed with the NCACPA to offer online ethics courses. Through this partnership, a percentage of the revenue generated benefits ECU students enrolled in our MSA program that plan to pursue a career in public accounting. This year's scholarship recipients are reported in the "Student News" section of the newsletter.
